Treasurer Report

Honeoye Lake Watershed Task Force

The Board Discussed the HVA board positions of Caroline and Terry.

Caroline has cleared that she can and will remain on the HVA board. Terry will remain on the HVA board, but there can be an opening on the HLTWF as Terry's seat on the HLWTF will be from his role as Canadice Town Board, not the HVA.

Finger Lakes Regional Watershed Alliance

DC put forth a motion to renew Finger Lakes Regional Watershed Alliance membership for \$200.00. Don cook motion Jerry P Second, Ayes unanimous.

Water Shed Educational Programs

LW discussed his outreach for education program to the Richmond Rec program. No final actions using the Richmond Rec program to educate. LW again discuss with Holly at Richmond Rec.

LM detailed that the educators will submit invoice to endga and the HVA will reimburse the endga water shed, to avoid a 1099.

DB mentioned the recent Mueller Foundation grant to expand education at the Mueller Field Station.

DB recommended we talk to HCS about using Muller field Station. The HVA might be able to reimburse the HCS if some expenses like travel are holding them back from taking students to Mueller. FYI - Muller field station is available for year round education. Jerry P will talk with the board of education to see the level of support and path forward. JP asked that if we can get him grade specific material details, he will meet with superintendent to get him possibly on board to promote education programs in and out of HCS.

- LM there may be more teachers interested in the education program, they may be the go to people.
- JP advised we have to get information in front of educators in time for them to plan with in their curriculum..
- DB pointed out how well the cndga watershed education program fits in the curriculum with the school districts.

DB suggested sponsoring students to the DEC camps. DEC camps are residential for kids, essay contest for the students, HVA to pay for a camp week for the students. No action on this yet.

Discussion of NY HAB Announcement and plan for community communication

Board discussed we may want the symposium to be the presentation vehicle of what is known about the NY \$65M grant for HHAB's announcement. The timing might be right to present projects that are proposed, projects that are approved, etc IF ANY! It was noted that **Nothing** is approved or moving anywhere at this time as there is no state budget presented or approved or processes on how the money could be used. If more is known earlier than the symposium, HVA might offer to host a meeting by the HLWTF to present and facts that are available for the community. The HLWTF is the sole driver of our participation in this program.

Honeoye lake water shed task force

• LM and DB discussed sharing a seat to represent the HVA on the task force, with Lindsay letting DB know if she cannot attend so that he can. No Decision was made.

Take Back the Lake meeting several members are considering attending.

CSLAP Program:

- HVA Board would like to explore volunteers to help gather information CSLAP. The possibility of a mentoring program for projects on Honeoye Lake.
- Explore volunteer opportunities to educate the public to gather information in the macraphyte program and the CSLAP Citizen State Wide Lake Assessment program. Citizen Scientists. HVA Board may want to drive an HVA CSLAP program. Get people involved and generate ownership.
- Symposium, possibly have a CSLAP presentation to rally volunteers for participants.
