- Members found it desirable to have additional lake residents especially in the north basin participate in FLI's invasive macrophyte survey. Lindsay informed that FLI has a recruiting campaign and that she will look through FLI's Facebook page for information HVA can use. HVA will wait until spring when FLI kicks-off their 2021 program to start communicating to members/residents about this volunteer opportunity.
- Although board members were not too keen on the idea of a calendar, there was discussion regarding the photo contest. Discussion included having two contests per year, one in winter and one in summer. Additionally, the contest format was discussed so that the entries would be made and voted on via Facebook instead of entries being mailed to HVA and voted on at the annual meeting as was done in the past. Dan and Lindsay are going to work out the logistics for using Facebook.
- Elaine sent Dan a humorous podcast for Dan to use on HVA Facebook page.

<u>LED Flares</u>: Terry had sent the board members an email from Greg Talomie from Canandaigua Lake who has been actively promoting the use of LED flares instead of traditional flares during the Ring of Fire events. Greg's email stated that Wegman's has joined the LED flare movement and that going forward, will only be selling LED flares. In principle, the board members support the use of LED flares instead of traditional flares but want feedback from the Fire Department before we take a formal position.

Lake Friendly Living: Terry clarified that he did not offer to make a presentation at the Lake Friendly Living consortium event in May but would merely share a brochure with the board members that HVA developed several years ago on friendly lake living. Terry also emailed a presentation on "Healthy Lawn Healthy Lake living" rain barrels that was made a couple years ago by Ontario County Soil and Water. Craig and Lindsay had no new information regarding the May event except that it is progressing, and reiterated that information/ presentations during the event could be shared among lake associations. It was mentioned that Lake George will release their Lake Friendly Living guide pending new Adirondack Park Agency (APA) regulations. Once released, other lake associations could leverage the Lake George guide for their own Lake Friendly Living campaigns.
